#### **Dr. Ayodele Odusola,**

UNDP Regional Bureau for Africa

Chief Economist and Lead Editor Income Inequality Trends in Sub-Saharan Africa (UNDP 2017)

Ayodele Odusola is a Nigerian national and holds a PhD in Economics from the University of Ibadan, Nigeria. He provides strategic leadership on development strategy, policy analysis and knowledge products on Africa. Further, he coordinates the preparation of regional flagship reports. Dr. Odusola also provides intellectual leadership to SDG acceleration frameworks in sub-Saharan Africa, managing the network of Senior Economists in UNDP Africa Country Offices and providing strategic advice on policy matters. He has supported many African governments on the preparation of national development plans, strategies and visions. As an economist, Dr. Odusola focuses on dynamics of macroeconomics and development economics pertaining to the African continent.

#### **Gottfried von Gemmingen**

German Federal Ministry for Economic Cooperation and Development (BMZ), Head of Division

Gottfried von Gemmingen leads a team of senior policy officers and administrative staff to coordinate the BMZ's contribution to implement the 2030 Agenda by supporting international policy processes and initiatives, cooperating with developing country partners and taking global responsibility through domestic action.

Before, he represented Germany in the UNFCCC negotiations on climate change adaptation issues since 2010. As a policy advisor at BMZ, he helped to capitalize African Risk Capacity and other climate risk insurance funds, establish the National Adaptation Plan (NAP) Global Network and prepare the G7 climate risk insurance initiative "InsuResilience" and the G20 "Global Partnership for Climate and Disaster Risk Finance and Insurance". He served as the Co-Chair of an OECD task team on adaptation and was a founding member of the Executive Committee of the Warsaw International Mechanism on Loss and Damage under UNFCCC.

#### **Prof. Murray Leibbrandt**

University of Cape Town, Southern Africa Labour and Development Research Unit (SALDRU), Director

Murray Leibbrandt is a Professor in the School of Economics at the University of Cape Town and the Director of the Southern Africa Labour and Development Research Unit (SALDRU). He holds the DST-NRF South African Research Chair Initiative (SARChI) Chair in Poverty and Inequality Research and is an IZA Research Fellow. His research focuses on South African poverty, inequality and labour market dynamics using survey data and in particular panel data. He is currently one of the Principal Investigators on the National Income



Dynamics Study (NIDS). He is a past president of the African Econometric Society and immediate past president of the Economic Society of South Africa.

### **Dr. Minu Hemmati**

##### Brief description and objective

Why and how can we measure inequality of opportunity?

This session will engage participants to think about the importance of understanding and measuring inequality of opportunity, an important process for any society that values cohesion and aims to address injustice. During the session, participants will consider key opportunities that would need to be measured in the context of their region/ subregion/ countries. They will also learn about how inequality of opportunity is shaping in Asia-Pacific countries. Participants will also engage in debate on how Southern African countries could better monitor inequality of opportunity.

The objective is to increase capacity of participants to define and measure inequality of opportunity in their own country's context.

##### **Poverty, Inequality and Redistribution - How can the redistributive capacity of states be increased?**

We will discuss the toolkits, methods, and indicators that are available to researchers interested in measuring and improving the public sphere's capacity for inequality and poverty reduction.

Participants should understand the breadth and depth of analytical output available from, as well as the advantages and disadvantages of, comprehensive fiscal incidence analysis using micro datasets and budgetary/administrative data.

##### **Economic growth, inequality and poverty: understanding trends and implications for policy**

### Brief description and objective

Why has growth in the region not led to declines in poverty or inequality? And what can be done to reduce inequality and ensure faster progress in poverty reduction going forward? The session will explore recent trends in the relationship between growth, poverty and inequality at the regional level and will focus on the drivers of persistent inequality in South Africa. Lessons from recent policy approaches and policy simulations to address inequality will also be presented followed by a discussion on what this means for policy going forward in South Africa.

The objective is to identify drivers of the persistent inequality in Southern Africa, particularly South Africa, and discuss policy options to address them.

#### Brief description and objective

Addressing inequalities requires coordination between different actors and an integrated approach, however the bigger responsibility falls on governments as they are at the center of policy making. Governments have significant roles in designing policies, strategies and plans for development.

Recognizing that governments have a bigger role to play, the objective of this particular session is to have an in-depth discussion on the role of national governments in reducing inequalities, both income and non-income dimensions, by building on country specific experiences.

The session is expected to discuss on choices of policies and tools governments can utilize in their goal of reducing inequalities. It is also expected to cover the challenges and constraints based on country experiences and shade light on what kind of policies are preferred in certain situations so as to have cross learning from each other.

It is also essential that there is strong participation from the African researcher community in the very active discussions of African inequality.

This session will explore the goals and workplan of ACEIR as a case study to discuss and hone the role of African researchers and research institutions within broader strategies to overcome inequality in Africa.

The objective is to discuss and sharpen the role of academic researchers and research institutions within the evidence to policy change pipeline of strategies to overcome inequality, and to introduce ARUA's African Centre for Inequality Analysis (ACEIR) within this context.

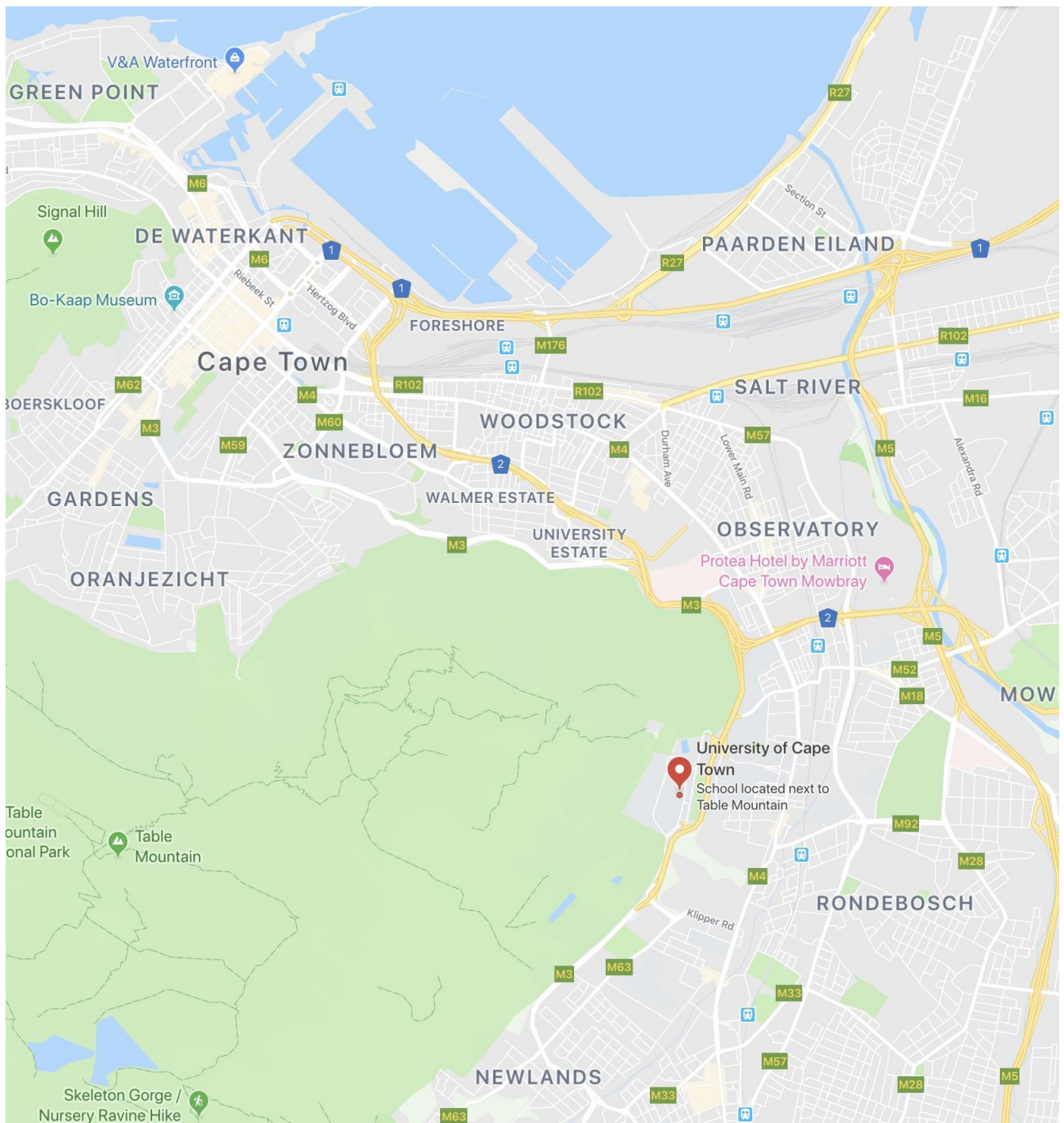
